TRUST FUND AGREEMENT BETWEEN THE  
UNITED NATIONS INDUSTRIAL DEVELOPMENT ORGANIZATION  
AND THE GOVERNMENT OF .....

WHEREAS the United Nations Industrial Development Organization (hereinafter "UNIDO") and the Government of ..... (hereinafter "the Donor") have agreed to cooperate in the implementation of a Project in ..... entitled "....." (hereinafter referred to as "the Project"), which Project is more fully described in the Project Document No. ...., which has been signed by the Government of ....., and which is attached as Annex A hereto and made an integral part hereof;

WHEREAS UNIDO has made an additional financial contribution to the Integrated Programme in the amount of USD ....., the Donor has informed UNIDO of its willingness to contribute additional funds to meet the costs of the Project;

NOW THEREFORE, UNIDO and the Donor hereby agree to extend the previously signed Trust Fund Agreement subject to the following amendments:

#### ARTICLE I

1. The Donor shall, in the manner referred to in paragraph 2 below, place at the disposal of UNIDO a sum of USD ....., bringing the total contribution to USD ..... and UNIDO shall use such funds to meet the costs of the Project, including programme support costs.

2. **ARTICLE III**

1. UNIDO shall continue to conduct operations under this Trust Fund Agreement upon receipt of a copy of this Amendment, signed by both Parties, and upon receipt of sufficient funds in accordance with Article I and Annex B1.

2. The Donor undertakes to meet the actual costs of the services specified in the Project Document in Annex A to the Trust Fund Agreement and this Amendment, and UNIDO undertakes not to make any commitments for services not specified in the Project Document without the approval, in writing, of the Donor.

**ARTICLE XII**

This Amendment shall enter into force upon signature.
