Introduction

- 1. The report of the Industrial Development Board on the work of its twenty-sixth session is presented to the General Conference in accordance with Article 9.4 (c) of the Constitution. The summary records of the Board (IDB.26/SR.1-6), where the details of the proceedings are contained, form an integral part of the present report.
- 2. The following decisions of the Board, reproduced in annex I, are related to the work of the General Conference at its tenth session:

IDB.26/Dec.4 Proposed payment plan for Azerbaijan

I. ORGANIZATIONAL AND PROCEDURAL MATTERS

3. The twenty-sixth session of the Board was held at UNIDO Headquarters, Vienna International Centre, from 19 to 21 November 2002 (6 plenary meetings—see IDB.26/SR.1-6).

Participation

4. - 5. The following 40 Member States of UNIDO also participated in the session: Afghanistan, Angola, Argentina, Azerbaijan, Bosnia and Herzegovina, Brazil, Cameroon, Cape Verde, Cyprus, Czech Republic, Democratic People's Republic of Korea, Finland, Iraq, Kuwait, Lebanon, Lithuania, Madagascar, Malaysia, Mexico, Mozambique, Namibia, Netherlands, New Zealand, Oman, Panama, Poland, Portugal, Romania, Rwanda, Senegal, Sierra Leone, Slovakia, South Africa, Uganda, Ukraine, United Arab Emirates, Viet Nam, Yemen, Yugoslavia, Zimbabwe.
- 6. The Holy See participated as observer.

Opening of the session

11. The twenty-sixth session of the Board was declared open by its President, Mr. I. Horváth (Hungary).

Officers of the session

12. The other officers of the twenty-sixth session were those elected at the commencement of the first regular session in 2002: Mr. R. González Aninat (Chile), Mr. S. Shoukry (Egypt), Mr. Y. Takasu (Japan) as Vice-Presidents and Mr. M. Hamedani (Islamic Republic of Iran) as Rapporteur.

- 14. The Board adopted a proposal by the President to ensure the maximum utilization of available conference-servicing resources (see annex I, decision IDB.26/Dec.1, IDB.26/SR.1, paras. 2 and 3).
- 15. The Board decided to set up informal, in-session consultations with the aim of facilitating the drafting of decisions and entrusted Vice-President Mr. Y. Takasu (Japan) to chair those consultations (see IDB.26/SR.2, paras. 1 and 2).

II. REPORT OF THE PROGRAMME AND BUDGET COMMITTEE (item 2)

16. The Board decided to discuss simultaneously subitems (a) to (c) and (e) followed by subitem (d). The debate on those subitems is reflected in summary records IDB.26/SR.1, paragraphs 53 to 61, IDB.26/SR.2, paragraphs 24 to 72 and IDB.26/SR.5, paragraphs 17 and 18. The Board had before it the report of the Programme and Budget Committee on the work of its eighteenth session (IDB.26/13) and the documents mentioned under A to E below.

A. Report of the External Auditor, financial performance report and programme performance report for the biennium 2000-2001

17. The Board had before it the Report of the External Auditor on the accounts of the United Nations Industrial Development Organization and of the Industrial Development Fund for the financial period 2000-2001 ended 31 December 2001 (IDB.26/2) and the comments of the Director-General thereon (IDB.26/3), as well as the financial performance report for the biennium 2000-2001 submitted by the Director-General (IDB.26/5) and the programme performance report for 2001 which is included in the Annual Report 2001 (IDB.25/2 and Add.1). The Board considered a draft decision submitted by the President (IDB.26/L.2) and adopted decision IDB.26/Dec.2 (see annex I).

B. Financial situation of UNIDO

18. The Board had before it a report by the Director-General on the financial situation of UNIDO (IDB.26/9), a report by the Director-General on a proposed payment plan for Azerbaijan (IDB.26/16), an addendum thereto containing paragraph 7 of the draft payment plan (IDB.26/16/Add.1) as well as a conference room paper on the financial situation of UNIDO (IDB.26/CRP.2) submitted by the Secretariat. The Board considered two draft decisions submitted by the President (IDB.26/L.3 and IDB.26/L.11) and adopted decisions IDB.26/Dec.3 and IDB.26/Dec.4 (see annex I).

C. Financial regulations

19. The Board took note of the entry contained in the annotated agenda (IDB.26/1/Add.1) that no further meetings of the Intersessional working group on proposed amendments to the financial regulations were scheduled.

D. Mobilization of financial resources

20. The Board had before it a report by the Director-General on mobilization of financial resources for UNIDO programmes (IDB.26/6), as well as information contained in the Annual Report 2001 on financial resources—funds mobilization (IDB.25/2, chap. V.A) and on project approvals under voluntary contributions (IDB.25/2, Appendix B). The Board considered a draft decision submitted by the President (IDB.26/L.4) and adopted decision IDB.26/Dec.5 (see annex I).

E. Transition to a single currency system

21. The Board had before it a note by the Secretariat on transition to a single currency system (IDB.26/4). The Board considered a draft decision submitted by the President (IDB.26/L.5) and adopted decision IDB.26/Dec.6 (see annex I).

III. PROGRAMMATIC REVIEW, INCLUDING SYSTEM-WIDE ISSUES (item 3); MEDIUM-TERM PROGRAMME FRAMEWORK, 2004-2007 (item 4)

22. The Board decided to discuss simultaneously item 3, including sub-items (a) to (c), and item 4. Under item 3, the Board had before it two conference room papers, one on status of the integrated programmes (IDB.26/CRP.4) and one on technical cooperation: role and responsibilities of United Nations entities (IDB.26/CRP.5). The debate on those items is reflected in summary records IDB.26/SR.2, paragraphs 3 to 9, IDB.26/SR.3, paragraphs 1 to 114 and IDB.26/SR.4, paragraphs 1 to 69.

A. UNIDO participation in major international events

23. The Board had before it, under item 3 (a), a report by the Director-General on programmatic review, including system-wide issues: UNIDO participation in major international events (IDB.26/12 and Corr.1).

B. Implementation of medium-term programme framework, 2002-2005, including field representation and technology foresight

24. The Board had before it, under item 3 (b), a report by the Director-General on implementation of medium-term programme framework, 2002-2005 (IDB.26/7 and

Corr.1) and a note by Japan on improved UNIDO programme delivery (IDB.26/15). The Board considered a draft decision submitted by the President (IDB.26/L.8) and adopted decision IDB.26/Dec.7 (see annex I).

C. Global biotechnology forum

25. The Board had before it, under item 3 (c), a note by the Secretariat on global biotechnology forum (IDB.26/10). The Board considered a draft decision submitted by the President (IDB.26/L.9) and adopted decision IDB.26/Dec.8 (see annex I).

D. Medium-term programme framework, 2004-2007 (item 4)

26. The Board had before it, under item 4, proposals of the Director-General for the medium-term programme framework, 2004-2007 (IDB.26/8) and a note by Japan on improved UNIDO programme delivery (IDB.26/15). The Board considered a draft decision submitted by the President (IDB.26/L.8) and adopted decision IDB.26/Dec.7 (see annex I).

IV. PERSONNEL MATTERS (item 5)

27. The Board had before it a report by the Director-General on personnel matters (IDB.26/11). The debate on item 5 is reflected in summary record IDB.26/SR.5, paragraphs 1 to 16. The Board considered a draft decision submitted by the President (IDB.26/L.6) and adopted decision IDB.26/Dec.9 (see annex I).

V. CONSULTATIONS WITH NON-MEMBER STATES (item 6)

28. The Board had before it a report by the Director-General on consultations with non-Member States (IDB.26/14 and Corr.1) and a conference room paper on the same subject (IDB.26/CRP.6). The debate on item 6 is reflected in summary record IDB.26/SR.5, paragraphs 1 to 16. The Board considered a draft decision submitted by the President (IDB.26/L.10/Rev.1) and adopted decision IDB.26/Dec.10 (see annex I).

VI. PROVISIONAL AGENDA AND DATE OF THE TWENTY-SEVENTH SESSION (item 7)

29. The Board had before it a conference room paper containing a note by the Director-General on the provisional agenda and date of the twenty-seventh session (IDB.26/CRP.3). The debate on item 7 is reflected in summary record IDB.26/SR.5, paragraphs 19 to 21. The Board considered a draft decision submitted by the President (IDB.26/L.7) and adopted decision IDB.26/Dec.11 (see annex I).

VII. ADOPTION OF THE REPORT (item 8)

30. The Board considered the draft report (IDB.26/L.1) and adopted it as a whole with the understanding that the Rapporteur would be entrusted with the task of finalizing the report (see summary record IDB.26/SR.6, paras. 30 to 32).

IDB.26/Dec.1 UTILIZATION OF AVAILABLE CONFERENCE-SERVICING RESOURCES

The Industrial Development Board, with the aim of utilizing the available conference-servicing resources to the maximum possible effect, decided to suspend with immediate effect rule 32 of its rules of procedure relating to the quorum, for the meetings of its twenty-sixth session only and provided no substantive decisions were taken at those meetings.

1st plenary meeting 19 November 2002

IDB.26/Dec.2 REPORT OF THE EXTERNAL AUDITOR, FINANCIAL PERFORMANCE REPORT AND PROGRAMME PERFORMANCE REPORT FOR THE BIENNIUM 2000-2001

The Industrial Development Board:

- (a) Took note of the report of the External Auditor on the accounts of the United Nations Industrial Development Organization and of the Industrial Development Fund and trust funds for the financial period 2000-2001 ended 31 December 2001 (IDB.26/2);
- (b) Also took note of the Director-General's comments on the report of the External Auditor (IDB.26/3);
- (c) Welcomed the positive assessment made by the External Auditor, which, inter alia, states that the financial statements reflect properly the recorded financial transactions for the biennium ended 31 December 2001 and present fairly, in all material respects, the Organization's financial position as at 31 December 2001 and that the Organization had achieved relevance, financial stability, improved technical cooperation and delivery and quality of services through more focused activities during the last four years (IDB.26/2, annex I and para. 136);
- (d) While acknowledging that the External Auditor had not found any specific weakness or violation of internal controls, misconduct or undue behaviour in the field, took note of the concerns expressed by the Auditor that the Internal Oversight Group was not in a position to perform intensive as well as extensive systematic reviews as required (paras. 96, 97 and 129 of the report);
- (e) Bore in mind that the Joint Inspection Unit had recommended in its report JIU/REP/98/2 that the

legislative organs request the executive heads to submit a consolidated annual summary report, as distinct from individual reports, on internal oversight activities;

- (f) With regard to the External Auditor's recommendations pertaining to internal oversight, requested the Director-General:
 - (i) To inform the Industrial Development Board of major internal oversight activities on the weaknesses of systems, procedures and related internal controls as called for under financial rule 109.39, including issues addressed, accomplishments achieved, a summary of recommendations made and status of action taken, through the Annual Report of the Director-General on the activities of the Organization;
 - (ii) To inform the External Auditor as "cases of presumptive fraud" of any fraud-oriented investigation undertaken by the Internal Oversight Group;
 - (iii) To strengthen the internal oversight function, in a systematic manner, inter alia, through an improved staffing profile with as much independence as practicable, in order to ensure proactive reviews of all operations of the Organization to assess compliance, economy and efficiency and effectiveness of systems, procedures and related internal controls, including the engagement of experts, procurement of equipment and subcontracting under technical cooperation activities:
 - (iv) To report to the Board at its twenty-seventh session on the implementation of the above request pertaining to internal oversight;
- (g) With regard to other important aspects of the External Auditor's report, further requested the Director-General to report to the Board at its twenty-seventh session in more detail on efforts to meet the recommendations of the External Auditor, in particular:
 - (i) On measures taken to increase fraud awareness and to combat fraud (paras. 92-99 of the report):
 - (ii) With regard to UNIDO's offices at New York and Geneva (para. 128), also in response to the need for closer cooperation with the European Commission and the EuropeAid Co-operation Office in Brussels;
 - (h) Requested the External Auditor:

- To include in future reports a table with the key recommendations, in order to increase the clarity and action-oriented nature of the reports;
- (ii) To submit each year in time for the appropriate Programme and Budget Committee session a short interim report on the activities carried out by the External Auditor and any recommendations resulting therefrom, bearing in mind that the External Auditor can only certify the accounts at the end of the biennium;
- (i) Requested the Director-General:
- (i) To submit proposals to the Programme and Budget Committee at its nineteenth session to deal with the problem of UNIDO's After-Service Health Insurance liabilities in the event of a United Nations-wide solution not being forthcoming;
- (ii) To differentiate in future financial performance reports between unutilized balances that are a result of cost-saving measures undertaken, lack of resources, delivery problems and the like;
- (iii) To complete the table mentioned in paragraph (h) (i) above by explaining the response to these recommendations by the time of the following session of the Programme and Budget Committee.

IDB,26/Dec.3 FINANCIAL SITUATION OF UNIDO

The Industrial Development Board:

- (a) Took note of the information provided in document IDB.26/9;
- (b) Also took note of the information contained in chapter VI and annex II of that document on the implementation of General Conference decision GC.9/Dec.10;
- (c) Urged those Member States and former Member States that had not yet paid their assessed contributions, including advances to the Working Capital Fund and prior years' arrears, to do so without delay;
- (d) Requested the Director-General to pursue his efforts and contacts with Member States to effect the collection of arrears;

- (e) Requested the Secretariat to ascertain from other organizations in the United Nations system information as to the incentives and disincentives in place with regard to the payment of assessed contributions as well as to the linking of such incentives and disincentives to services provided and to report thereon to the Committee at its nineteenth session;
- (f) Recommended to the General Conference at its tenth session to allow the Secretariat to use for integrated programmes or country service frameworks each country's share and amount of the unencumbered balances of appropriations, income from new Member States and interest income in excess of budgetary estimates, as specified in decision GC.9/Dec.10, if no response had been received by 31 December 2003 from the concerned States on the use of those funds amounting to &840,818, as contained in annex II to document IDB.26/9;
- (g) Requested the Director-General to send a final reminder to those Member States that had not yet replied, informing them of the present decision.

6th plenary meeting 21 November 2002

IDB.26/Dec.4 PROPOSED PAYMENT PLAN FOR AZERBAIJAN

The Industrial Development Board:

- (a) Recalled the Constitution of the Organization and the financial regulations in place, last amended by GC.9/Dec.14;
- (b) Also recalled the report of the open-ended discussion group on timely payment of assessed contributions (IDB.19/12 and Corr.1), in particular paragraphs 13 and 14, which had provided that normally the repayment period should not exceed five years;
- (c) Further recalled Board decisions IDB.19/Dec.5 and IDB.25/Dec.6;
- (d) Noted the information in documents IDB.25/8, IDB.26/16 and Add.1;
- (e) Welcomed the commitment of Azerbaijan to settle its arrears;
- (f) Decided to approve the payment plan negotiated with Azerbaijan as outlined in document IDB.26/16 and Add.1;
- (g) Took note, without prejudice to paragraph (b) above, of the terms of the payment plan and encouraged Azerbaijan to pay regularly its instalments in line with the conditions therein;

(h) Recommended to the General Conference to consider positively the request of Azerbaijan for the restoration of voting rights in accordance with Article 5.2 of the Constitution of UNIDO.

IDB.26/Dec.5 MOBILIZATION OF FINANCIAL RESOURCES

The Industrial Development Board:

- (a) Took note of the information contained in document IDB.26/6;
- (b) Decided to delegate to the Director-General the authority to approve projects for financing under the Industrial Development Fund in 2003 and 2004 in accordance with the priorities defined in the medium-term programme framework, 2002-2005 (GC.9/Res.2);
- (c) Urged all Member States to pay their assessed contributions to the regular budget in full and on time, so that UNIDO could develop and implement its programmes in an efficient manner;
- (d) Encouraged Member States and other financial sources to increase their voluntary contributions to UNIDO;
- (e) Also encouraged the donor community and other sources of financing to consider contributing programmable funds, specifically to enable UNIDO to implement the integrated programmes or country service frameworks, as well as to support an efficient development and eventual implementation of new initiatives within the mandate given to the Director-General in the medium-term programme framework, 2002-2005;
- (f) Encouraged Governments of recipient countries to play a more active role in assisting UNIDO within their means to mobilize funds for jointly developed integrated programmes or country service frameworks and other high-priority activities, and specifically to assist in identifying and accessing funds available at the country level, including cost-sharing arrangements, and funds from bilateral donors, UNDP, and from the World Bank and other development finance institutions;
- (g) Requested the Director-General in due time to enter into dialogue with all Member States on new initiatives within the framework and priorities of the medium-term programme framework, 2002-2005, including their financial implications, and promote them in the international development context especially

in international conferences and other forms of dialogue.

IDB.26/Dec.6 TRANSITION TO A SINGLE CURRENCY SYSTEM

The Industrial Development Board:

- (a) Took note of the information provided in document IDB.26/4 on the transition to a single currency system, and in particular of the problems faced;
- (b) Noted with satisfaction that the Director-General had begun to take steps towards the full implementation of the single currency system based on the euro;
- (c) Requested the Director-General to find solutions to the problems in implementation identified in document IDB.26/4 and to keep Member States regularly informed of further developments.

IDB.26/Dec.7 STRATEGIC GUIDELINES "TOWARDS IMPROVED UNIDO PROGRAMME DELIVERY"

The Industrial Development Board:

- (a) Recalled General Conference resolution GC.7/Res.1 of 4 December 1997 endorsing the Business Plan on the Future Role and Functions of UNIDO, which remains the basis of UNIDO's organizational and programmatic transformation;
- (b) Also recalled General Conference resolution GC.9/Res.2 of 7 December 2001 concerning the medium-term programme framework, 2002-2005;
