I. Overview

1. The financial situation as at 31 March 2007 can be summarized in the following major points:

- (a) Regular budget net expenditure for the first year of the biennium 2006-2007 amounted to €60.1 million in 2006, or 81.8 per cent of the approved 2006 net budget estimates. As at 31 March 2007, €82.9 million or 53.8 per cent of the biennial appropriation was spent;
- (b) Operational budget expenditure amounted to €7.8 million in 2006. Support cost and other income during 2006 amounted to €9 million, resulting in an increase in the level of the operating reserve from €5.1 million as at 1 January 2006 to €6.8 million as at 31 December 2006. In the first quarter of 2007, additional support cost income of €2 million and expenditure of €1.9 million were recorded;
- (c) The expenditure level for Buildings Management in 2006 amounted to €17.4 million;
- (d) The level of regular budget cash resources (including the Working Capital Fund) was €59.1 million. In comparison, the cash balance as at 31 March 2006 and 2005 was €53.3 million and €50.6 million, respectively;
- (e) The collection rate of 2007 assessed contributions was 40.8 per cent, compared to the 2006 and 2005 rates of 51 and 58.6 per cent, respectively. However, some major contributors' payments are expected within the next months;
- (f) The collection rate of prior years' arrears, as compared to the current year's assessments, was 1.3 per cent. The rates as at 31 March 2006 and 2005, as compared to the assessments of those years, were 0.9 and 2.3 per cent, respectively;
- (g) Outstanding assessed contributions amounted to €162.6 million, as shown in the annex to the present document (including arrears of €69.2 million by the United States of America, and €2.1 million by the former Yugoslavia). The outstanding amounts as at 31 March 2006 and 2005 were €156.2 million and €145.2 million, respectively;
- (h) The Working Capital Fund was at the level of €7,423,030. However, an amount of €7,328 was outstanding as at 31 March 2007;
- (i) The supplementary estimates for the biennium 2004-2005 for security enhancements was approved by the General Conference (GC.11/Dec.15) at the level of €2,585,160 and the amount outstanding for collection was €141,431 on 31 March 2007;
- (j) Unencumbered balances of appropriations amounted to €1,719,678 and the respective share was distributed to eligible Member States with the 2007 assessments;
- (k) A conference room paper will provide information on the status of assessed contributions and voting rights, updated to 27 April 2007.

II. Regular and operational budgets, 2006-2007

Regular budget

2. In the first year of the biennium, the implementation of the approved programme and budgets progressed as planned. In line with a 92 per cent expected collection rate of assessed contributions and the otherwise healthy cash position of the Organization at the beginning of 2006, an average release of allotments in the amount of some 98 per cent of the originally planned gross expenditure was approved for 2006, including UNIDO's share of Buildings Management Services. While resources were released in full for the budget items Regular Programme of Technical Cooperation and Special Resources for Africa, reduced allotment levels were approved under certain objects other of expenditure. Allotments for staff costs, indirect costs and headquarters operating costs were approved at 100 per cent.

3. By 31 December 2006, regular budget net expenditures amounted to €60.1 million. This amount corresponds to 81.8 per cent of the total approved net regular budget for 2006. In the first year of the preceding biennium (2004), a slightly lower implementation rate of 81.1 per cent was recorded.

4. The expenditure level during 2006 was mainly attributable to the high number of vacant posts inherited from the previous biennium. While a structured recruitment effort was initiated as early as June 2006, the financial impact will show only at a later stage.

5. As at 31 March 2007, total regular budget allotments for the biennium amounted to €141.7 million, i.e. 92 per cent of the gross expenditure budget. Expenditures amounted to €82.9 million, corresponding to 53.8 per cent of the gross budget. The same expenditure indicator as at 31 March 2005 showed 54 per cent.

Operational budget

6. In the operational budget, total income, most of it being reimbursement for programme support costs, amounted to €9 million during 2006. Expenditures were recorded in the amount of €7.8 million, resulting in an excess of income over expenditure in the amount of €1.2 million. Savings on cancellation of prior biennium obligations further increased the excess of income over expenditure by €0.5 million and thus the net surplus for the period amounted to €1.7 million. The resulting closing balance of the special account for programme support costs was €6.8 million as compared to the opening balance of €5.1 million. In accordance with decision IDB.30/Dec.2, the operating reserves were adjusted to €3.03 million, or 15 per cent of the estimated 2006-2007 biennium expenditure of the operational budget.

7. The delivery of technical cooperation activities in 2006 amounted to \$113.7 million, representing an increase of \$14.9 million. Compared with the 2005 amount of \$112.9 million, the delivery for 2006 shows a slight increase of \$0.8 million mainly attributable to the increase in trust funds and Montreal Protocol activities.

Buildings management

8. The Buildings Management Services budget has been implemented according to the prevailing work plan. Expenditures in 2006 amounted to €17.4 million. As compared to this, expenditure in 2004 – the first year of the previous biennium – amounted also to €17.4 million. As at 31 March 2007, €27.5 million was spent.

III. Assessed contributions

A. Collections

9. A total of 43 Member States, including five least developed countries (LDCs), have made full payments and 49 Member States, ten of which are LDCs, have made partial payments and/or their adjustments have been credited towards their assessed contributions for the year 2007. The collections in the period from January to March 2007, broken down by List of States, are shown in table 1.

10. The detailed status of assessed contributions outstanding as at 31 March 2007 is contained in the annex to the present document. The scale of assessment and outstanding contributions as at 31 March 2007, broken down by List of States, are shown in table 2.

IV. Voting rights

11. As indicated in the annex to the present document, the voting rights of 43 Member States had been suspended as at 31 March 2007 (the lowest number since 1994) in accordance with Article 5.2 of the Constitution and financial regulation 5.5 (b), as shown in table 3.

12. In order to restore their voting rights for 2007, these Member States must pay their full contributions for 2004 and prior years, including advances to the Working Capital Fund, as well as a partial contribution for 2005. The minimum total amount that would have to be paid by these Member States is €33,573,540.

V. Implementation of recommendations of Group on Timely Payments

13. Table 4 shows, in summary form, the current status of those Member States that have entered into payment plan arrangements to settle outstanding assessed contributions. Negotiations are currently ongoing with a number of Member States, in particular with Brazil, Costa Rica, Georgia, Moldova and Nicaragua. The Democratic Republic of the Congo signed a payment plan on 12 December 2005; however, as no payment has been received so far, the plan is not operational. Other

Member States in arrears are encouraged to consider submitting payment plans to steadily reduce their outstanding assessed contributions. The Secretariat notes with appreciation the considerable efforts made by all those Member States that have honoured their commitments and obligations as stipulated in their respective payment plans.

Incentives and disincentives

14. Since reporting in document GC.11/13, there has been no further development on this topic. The United Nations Committee on Contributions is still awaiting guidance thereon from the General Assembly.

Arrears by former Member States

15. The amounts owed to UNIDO by the United States are as follows:

Payment of these arrears is being pursued by the Secretariat with the Permanent Representative of the United States of America to the United Nations in Vienna.

16. Arrears of the former Yugoslavia amount to €2,081,599 (1990-2001). As stated in previous documentation to the governing bodies, the issue as to resolving this case on a system-wide basis is still pending a decision of the General Assembly.

VI. Unencumbered balances of appropriations and interest income in excess of budgetary estimates

17. Amount distributed to Member States in January 2007: The unencumbered balances of appropriations relating to the bienniums 1992-1993 and from 1996 to 2003, amounted to €1,719,678 and the respective share was distributed to eligible Member States in January 2007 (i.e. those that had fully paid their assessed contributions for the respective biennium) in accordance with financial regulations 4.2 (b) and (c).

18. Provisional amount due for distribution in January 2008: As at 31 March 2007, collections against unencumbered balances and interest income in excess of budgetary estimates amounted to €4.9 million due for distribution to eligible Member States.

VII. Action required of the Committee

19. The Committee may wish to consider recommending to the Board the adoption of the following draft decision:

“The Industrial Development Board:

“(a) Takes note of the information provided in document IDB.33/7-PBC.23/7;

“(b) Urges those Member States and former Member States that have not yet paid their assessed contributions, including advances to the Working Capital Fund and prior years’ arrears, to do so without delay;

“(c) Requests the Director-General to pursue his efforts and contacts with Member States to effect the collection of arrears.”
