Introduction

- 1. The report of the Industrial Development Board on the work of its thirty-fifth session is presented to the General Conference in accordance with Article 9.4 (c) of the Constitution. The summary records of the Board (IDB.35/SR.1-SR.4), where the details of the proceedings are contained, form an integral part of the present report.
- 2. The following decision of the Board, reproduced in annex I, is related to the work of the General Conference at its thirteenth session:

IDB.35/Dec.5 Medium-term programme framework, 2010-2013

I. Organizational and procedural matters

3. The thirty-fifth session of the Board was held at UNIDO Headquarters, Vienna International Centre, from 2 to 3 December 2008 (4 plenary meetings – see IDB.35/SR.1-4).

Participation

- 4. All 53 members of the Board were represented at the session: Afghanistan, Algeria, Austria, Belgium, Bolivia, Burkina Faso, China, Colombia, Costa Rica, Côte d'Ivoire, Cuba, Czech Republic, Ecuador, Egypt, Ethiopia, France, Germany, Ghana, Greece, Guatemala, Hungary, India, Iran (Islamic Republic of), Ireland, Italy, Japan, Kenya, Libyan Arab Jamahiriya, Luxembourg, Mexico, Morocco, Nigeria, Norway, Pakistan, Paraguay, Philippines, Poland, Republic of Korea, Romania, Russian Federation, Saudi Arabia, South Africa, Spain, Sri Lanka, Sudan, Sweden, Switzerland, Syrian Arab Republic, Thailand, Tunisia, Turkey, United Kingdom of Great Britain and Northern Ireland, Uruguay.
- 5. The following 46 Member States of UNIDO also participated in the session: Albania, Angola, Argentina, Armenia, Azerbaijan, Belarus, Brazil, Bulgaria, Cameroon, Cape Verde, Chile, Croatia, Cyprus, Democratic People's Republic of Korea, Dominican Republic, El Salvador, Finland, Indonesia, Israel, Jordan, Kuwait, Lebanon, Lesotho, Lithuania, Malaysia, Malta, Mongolia, Montenegro, Namibia, Netherlands, Oman, Panama, Peru, Portugal, Republic of Moldova, Senegal, Serbia, Slovakia, Slovenia, the former Yugoslav Republic of Macedonia, Ukraine, Venezuela (Bolivarian Republic of), Viet Nam, Yemen, Zambia, Zimbabwe.
- 6. The Holy See participated as observer.
- 7. Palestine participated as observer.
- 8. The Sovereign Military Order of Malta participated as observer.
- 9. The following United Nations bodies were represented: United Nations Human Settlement Programme (UN-Habitat), United Nations High Commissioner for Refugees (UNHCR).

- 10. The following United Nations specialized agencies and related organizations were represented: Food and Agriculture Organization of the United Nations (FAO), International Atomic Energy Agency (IAEA), World Trade Organization (WTO).
- 11. The following other intergovernmental organizations were represented: Asian-African Legal Consultative Organization (AALCO), Economic Cooperation Organization (ECO), European Commission, Institution for the Use of Micro-Algae Spirulina against Malnutrition (CISRI-ISP), International Institute of Refrigeration (IIR), International Organization for Migration (IOM).
- 12. The following non-governmental organizations were represented: Association of Former United Nations Industry and Development Experts (AFIDE), Austrian Senior Experts Pool (ASEP), Austro-Egyptian Chamber of Commerce, Forum Francophone des Affaires (FFA), Global Options and Linkages (GOAL), Institut Supérieur de Gestion (ISG), International Committee for Plastics in Agriculture (CIPA), International Congress of Industrialists and Entrepreneurs (ICIE), International Council of Women (ICW), International Federation of Agricultural Producers (IFAP), Mountain Unlimited, Organization of Islamic Capitals and Cities (OICC), Soroptimist International (SI).

Opening of the session

13. The thirty-fifth session of the Board was declared open by its President, Mr. H. Bazoberry Otero (Bolivia).

Officers of the session

14. The officers of the thirty-fifth session were those elected at the commencement of the first regular session in 2008: Mr. H. Bazoberry Otero (Bolivia) as President, Ms. K. Sinegiorgis (Ethiopia), Mr. A. Raiss Shaghaghi (Islamic Republic of Iran) and Mr. G. Kemmerling (Germany) as Vice-Presidents, and Ms. N. Vladulescu (Romania) as Rapporteur.

- 16. During the adoption of the agenda, statements were made by representatives of France on behalf of the European Union and Pakistan on behalf of the Group of 77 and China (see IDB.35/SR.1, paras. 3 and 4). The Board agreed not to take up consideration of agenda item 10, number and duration of sessions, but only to take note of the entry contained in the annotated agenda (IDB.35/1/Add.1).
- 17. The Board adopted a proposal by the President to ensure the maximum utilization of available conference-servicing resources (see annex I, decision IDB.35/Dec.1, IDB.35/SR.1, paras. 41 and 42).
- 18. The Board decided to set up informal in-session consultations with the aim of facilitating the drafting of decisions and entrusted Vice-President Mr. G. Kemmerling (Germany) to chair those consultations (see IDB.35/SR.2, paras. 8 and 9).

II. Report of the Programme and Budget Committee (item 2)

19. Under item 2, the Board decided to discuss simultaneously sub-items (a) to (e). The debate on these sub-items is reflected in summary records IDB.35/SR.1, paras. 43 to 90 and IDB.35/SR.2, paras. 10 to 27. The Board had before it the report of the Programme and Budget Committee on the work of its twenty-fourth session (IDB.35/2) and the documents mentioned under A to E below.

A. Report of the External Auditor, financial performance report and programme performance report for the biennium 2006-2007

20. Under item 2 (a), the Board had before it the report of the External Auditor on the accounts of UNIDO for the financial period 1 January 2006 to 31 December 2007 (IDB.35/3*), the financial performance report for the biennium 2006-2007 submitted by the Director-General (IDB.35/4) and the programme performance

report for 2007 which is included in the *Annual Report of UNIDO 2007* (IDB.34/2). The Board considered a draft decision submitted by the President (IDB.35/L.2) and adopted decision IDB.35/Dec.2 (see annex I).

B. Financial situation of UNIDO

21. Under item 2 (b), the Board had before it a report by the Director-General on the financial situation of UNIDO (IDB.35/5) and updated information on the financial situation of UNIDO (IDB.35/CRP.2). The Board considered a draft decision submitted by the President (IDB.35/L.3) and adopted decision IDB.35/Dec.3 (see annex I).

C. Accounting standards

22. Under item 2 (c), the Board had before it a progress report by the Secretariat on International Public Sector Accounting Standards (IDB.35/6). At the proposal of the President, the Board took note of the documentation provided.

D. Mobilization of financial resources

23. Under item 2 (d), the Board had before it a report by the Director-General on mobilization of financial resources (IDB.35/7), and information in the *Annual Report of UNIDO 2007* on funding performance (IDB.34/2, chapter 1.C), as well as information on projects approved under the Industrial Development Fund, trust funds and other voluntary contributions in 2007 (PBC.24/CRP.2). The Board considered a draft decision submitted by the President (IDB.35/L.4) and adopted decision IDB.35/Dec.4 (see annex I).

E. Medium-term programme framework, 2010-2013

24. Under item 2 (e), the Board had before it proposals of the Director-General on the medium-term programme framework, 2010-2013 (IDB.35/8) and comprehensive proposals of the Director-General entitled "Industrial development for poverty reduction, inclusive globalization and environmental sustainability – medium-term programme framework, 2010-2013" (IDB.35/8/Add.1 and Corr.1 (for English only)). The Board considered a draft decision submitted by the President (IDB.35/L.10) and adopted decision IDB.35/Dec.5 (see annex I).

III. Implementation of the medium-term programme framework, 2008-2011 (item 3)

25. Under item 3, the Board had before it a report by the Director-General on the implementation of the medium-term programme framework, 2008-2011 (IDB.35/14). The debate on this item is reflected in summary record IDB.35/SR.2, paras. 28 to 51. At the proposal of the President, the Board took note of the documentation provided.

IV. Cooperation Agreement with the United Nations Development Programme (item 4); United Nations system-wide coherence (item 6)

26. The Board decided to discuss simultaneously items 4 and 6. The debate on these items is reflected in summary records IDB.35/SR.2, paras. 52 to 84 and IDB.35/SR.3, paras. 1 to 9.

A. Cooperation Agreement with the United Nations Development Programme (item 4)

27. Under item 4, the Board had before it a report by the Director-General on the implementation of the Cooperation Agreement with the United Nations Development Programme (IDB.35/11). At the proposal of the President, the Board took note of the documentation provided.

B. United Nations system-wide coherence (item 6)

28. Under item 6, the Board had before it a report by the Director-General on United Nations system-wide coherence (IDB.35/12). At the proposal of the President, the Board took note of the documentation provided.

V. Global food crisis: UNIDO's response (item 5)

29. Under item 5, the Board had before it a report by the Director-General on the global food crisis: UNIDO's response (IDB.35/9). The debate on this item is reflected in summary record IDB.35/SR.3, paras. 10 to 60. At the proposal of the President, the Board took note of the documentation provided.

VI. Conclusion of Standard Basic Cooperation Agreements between UNIDO and Member States (item 9)

30. Under item 9, the Board had before it a note by the Director-General on the conclusion of basic cooperation agreements between Governments and UNIDO (IDB.35/15) and a conference room paper with the same title (IDB.35/CRP.5). The debate on this item is reflected in summary record IDB.35/SR.3, paras. 61 to 62. The Board considered a draft decision submitted by the President (IDB.35/L.5) and adopted decision IDB.35/Dec.6 (see annex I).

VII. Preparatory arrangements for the thirteenth session of the General Conference (item 11)

31. Under item 11, the Board had before it a report by the Director-General on preparatory arrangements for the thirteenth session of the General Conference (IDB.35/16). The debate on this item is reflected in summary record IDB.35/SR.3,

paras. 63 to 68. The Board considered a draft decision submitted by the President (IDB.35/L.8) and adopted decision IDB.35/Dec.7 (see annex I).

VIII. Personnel matters (item 7)

32. Under item 7, the Board had before it a report by the Director-General on personnel matters (IDB.35/13) and a conference room paper entitled "List of staff of the UNIDO Secretariat" (IDB.35/CRP.3). The debate on this item is reflected in summary record IDB.35/SR.3, paras. 69 to 74. The Board considered a draft decision submitted by the President (IDB.35/L.6) and adopted decision IDB.35/Dec.8 (see annex I).

IX. Matters related to intergovernmental, non-governmental, governmental and other organizations (item 8)

33. Under item 8, the Board had before it two notes by the Director-General on applications from non-governmental organizations for consultative status (IDB.35/10 and Add.1). The debate on this item is reflected in summary record IDB.35/SR.3, paras. 75 to 76. The Board considered a draft decision submitted by the President (IDB.35/L.7) and adopted decision IDB.35/Dec.9 (see annex I).

X. Provisional agenda and date of the thirty-sixth session (item 12)

34. Under item 12, the Board had before it a note by the Director-General on the provisional agenda and date of the thirty-sixth session (IDB.35/CRP.4). A statement on the item was made by the President and is reflected in summary record IDB.35/SR.4, para. 1. The Board considered a draft decision submitted by the President (IDB.35/L.9) and adopted decision IDB.35/Dec.10 (see annex I).

XI. Adoption of the report (item 13)

35. Under item 13, the Board considered the draft report (IDB.35/L.1) and adopted it as a whole with the understanding that the Rapporteur would be entrusted with the task of finalizing the report (see summary record IDB.35/SR.4, paras. 34 to 36).

XII. Closure of the session

36. On 3 December 2008, at 5.07 p.m., the Board closed its thirty-fifth session (see IDB.35/SR.4, paras. 37 to 39).

The Industrial Development Board:

- (b) Recognized the important contribution the External Auditor makes to the improvement of UNIDO's management, operations and performance through his recommendations;

The Industrial Development Board:

- (b) Decided to delegate to the Director-General the authority to approve projects for financing under the Industrial Development Fund in 2008 and 2009 in accordance with the priorities defined in the medium-term programme framework, 2008-2011 (IDB.32/8 and Add.1, and IDB.32/CRP.5);
- (c) Encouraged Member States and other donors to increase their voluntary contributions to UNIDO;
- (d) Also encouraged all donors to consider contributing programmable funds, specifically to enable UNIDO to implement the integrated programmes in a coordinated manner and achieve the synergy and increased impact envisaged in the integrated programme concept, as well as to support an efficient development and implementation of the new initiatives and thematic programmes responding to international development priorities;
- (e) Requested Member States to consider contributing to UNIDO to enable the Organization to participate in programmes requiring co-funding, either through contributing to dedicated trust funds or by special purpose funding at country or global level;
- (f) Further encouraged Governments of beneficiary countries to play an active role alongside UNIDO to mobilize funds for jointly developed programmes and other high-priority activities, and specifically to assist in identifying and accessing funds available at the country level, including cost sharing arrangements, and funds from bilateral donors, multi-donor trust funds, United Nations Development Programme, the World Bank and other development finance institutions;
- (g) Strongly recommended Member States to support UNIDO in its efforts to develop and promote its programmes and initiatives in the international development context, and especially through international conferences and other forms of dialogue, in order to ensure that these initiatives are well known, their relevance for international development targets recognized, and resources made available.

"Also welcoming the presentation of separate regional programmes in the medium-term programme framework for Africa, the Arab region, Asia and the Pacific, Europe and the Newly Independent States, Latin America and the Caribbean, including the introduction of region-specific response strategies;

- "(a) Recognizes that the medium-term programme framework is an important and flexible tool for implementing the Organization's mandates;
- "(b) Takes note with appreciation of the medium-term programme framework, 2010-2013;
- "(c) Invites the Director-General to report on the implementation of the medium-term programme framework in the annual report."
