## Annex I

#### LETTER FROM MINISTER OF FOREIGN AFFAIRS, UKRAINE

Excellency,

I have the honour to inform you that the Government of Ukraine would like to restore Ukraine's right to vote in the United Nations Industrial Development Organization (UNIDO) and to settle the problem of its arrears to the UNIDO budget.

The Government of Ukraine is in arrears in the payment of its financial contributions in an amount that exceeds the assessed contributions due from it for the preceding two fiscal years, resulting in the suspension of Ukraine's right to vote. The substantial arrears accumulated by Ukraine are the result of the outdated system of apportionment of the expenditures in the organizations of the UN system, which over many years was unable to adequately take into account the Member States' capacity to pay, as well as timely reflect the changes in their economic and financial potential. In addition, Ukraine has faced economic difficulties associated with its transition to the market economy and the need to allocate the substantial budget resources for resolving the Chernobyl-related problems. Thus, the Government of Ukraine believes that the failure to pay its assessed contributions has emerged due to conditions beyond its control.

In view of this, the Government of Ukraine hopes that, with the support of the Member States, the 9<sup>th</sup> session of the UNIDO General Conference will take a positive decision on the issue of restoring Ukraine's right to vote, based on the provisions of Article 5 of the UNIDO Constitution.

Being committed to the objectives of the UNIDO activities and wishing to continue fruitful cooperation with this Organization, the Government of Ukraine would like to settle its arrears to the UNIDO budget.

Following the consideration of this issue at the 24<sup>th</sup> session of the Industrial Development Board, my Government has held consultations with the UNIDO Secretariat which resulted in drafting an agreement between the Government of Ukraine and UNIDO on restructuring the debt for the period of 10 years. The Government of Ukraine has endorsed the draft agreement which is being submitted to the General Conference for its final approval. Under the payment plan, envisaged by the Agreement, Ukraine will pay its debt over a ten-year period, in addition to the current year's assessed contributions. As it is stipulated by the Agreement, the first instalment will be paid within two months of the approval by the General Conference of the proposed payment plan.

His Excellency Mr. Shaukat Umer President of the UNIDO General Conference Vienna Therefore, the Government of Ukraine is ready to settle its arrears, which have emerged due to the conditions beyond its control. In view of this, I would like to ask the General Conference to take a positive decision on Ukraine's request on restructuring its debt and restoring its right to vote, commencing with the 9<sup>th</sup> session of the General Conference.

I should be grateful if this letter could be made available to the Member States of the Organization.

Please, accept, Excellency, the assurances of my highest consideration.
