I wish to inform you that to my great regret I have to withdraw my candidature to extend for another two years the mandate as UNIDO's External Auditor.

Given the high and even increasing importance of UNIDO as a key player to solve global problems, serving as its external auditor has been an honour and a very rewarding exercise for me and my audit team.

However, the German SAI's schedule in the next six years will, unfortunately, not permit me any longer to devote to this important mandate the amount of time and consideration it deserves. Due to my new mandate and commitments as member of the United Nations Board of Auditors our staff for international audit mandates needed to be reallocated fundamentally. As such, auditors with crucial skills deployed by now in the UNIDO audit have been assigned to the UN audit team to effectively discharge the comprehensive and demanding set of tasks which the mandate on the United Nations Board of Auditors is entailing. Unfortunately, appropriate replacement for this staff is not available.

Therefore and once again, I would like to call on your understanding that I cannot maintain my candidacy for the extension of the mandate for another two years.
