STATE OF THE UNION

On 16 September 2020, the European Commission (EC) President Ursula von der Leyen delivered the annual "State of the Union" (SOTEU) address in front of the European Parliament (EP), presenting her vision for the European recovery from the pandemic. (All key documents here.)

She thanked Europe and its citizens for the resilience demonstrated in facing the pandemic, and praised the European socio-economic model, i.e. a "human economy that protects us against the great risks of life - illness, ill fortune, unemployment or poverty".

The EC president called for the EU to lead the recovery efforts, within Europe and globally. The EC President made no reference to the SDGs or the 2030 Agenda, and the speech largely took a European viewpoint, with little mentioning of the global socio-economic crisis, growing inequalities etc. However, the speech outlined a vision for a sustainable future and the EU's continued commitment to global solidarity and multilateralism.

The main instrument for the sustainable recovery will be the recovery fund "Next Generation EU". In her words, Next Generation EU is the opportunity to make change happen by design. The EU has the vision, plan and investment, and can now pass to action. In this sense, the EC

President sent a letter of intent to EP President and German Chancellor Merkel (EU Council Presidency) outlining the EC Plans for 2021.

"TEAM EUROPE" GLOBAL RESPONSE TO COVID-19: COUNCIL WELCOMES THE MOBILIZATION OF ALMOST €36 BILLION AND APPROVES CONCLUSIONS

The "Team Europe" package was launched on 8 April 2020 to support EU partner countries in the fight against the COVID-19 pandemic and its consequences. The financial support initially pledged was around 20 billion euro and combined resources from the EU, its member states, and financial institutions, in particular the European Investment Bank and the European Bank for Reconstruction and Development.

On 8 June 2020, the Council welcomed the mobilization of almost 36 billion euros through the Team Europe packages. The support of the European Union focuses on:

- responding to the immediate health crisis and the resulting humanitarian needs;
- strengthening health, water and sanitation systems, as well as partner countries' capacities and preparedness to deal with the pandemic;
- mitigating the immediate social and economic consequences, including support to the private sector with a focus on Small and Medium-sized Enterprises, and government reforms to reduce poverty.

CELEBRATING THE 75TH ANNIVERSARY OF THE UNITED NATIONS

The year 2020 marks a special anniversary for the United Nations: 75 years from the signing of the UN Charter in San Francisco.

In the last decades, the EU and the UN have been working hand in hand for peace, dialogue, and cooperation. The Covid-19 pandemic is once again showing how global challenges can be tackled and overcome only through global, coordinated action.

JOSEP BORRELL: A CREDIBLE ENLARGEMENT POLICY IS AN INVESTMENT IN PEACE AND SECURITY FOR THE WHOLE OF EUROPE.

The Commission adopted on 6 October 2020 the Enlargement package and the Economic and Investment plan for the Western Balkans. The Enlargement package assesses the state of implementation of reforms and presents recommendations to the six Western Balkans partners on their continued path towards the EU. The major Economic and Investment Plan for the Western Balkans aims to accelerate the long-term economic recovery of the region, support a green and digital transition, and foster the region's integration and convergence with the EU.

EU AID FOR TRADE PROGRESS REPORT 2020 PRESENTATION

On the 22nd of September a virtual presentation of the EU Aid for Trade Progress Report was held. The EU's Aid for Trade (AfT) strategy was adopted for the first time in 2007, in response to the Aid for Trade initiative launched by the World Trade Organisation (WTO) in 2005, which encouraged developing countries to recognise the role trade can play in their sustainable development. The EU's AfT strategy helps partner countries better integrate into the global trading system and take greater advantage of the poverty-reducing benefits of economic openness and enhanced trade efficiency. The EU Aid for Trade Progress Report 2020 reflects an important place of AfT in the development policies of the EU and its Member States, and the prioritisation of a stronger coherence between development, trade and investment instruments with a view to improve the economic, job creation and sustainability impacts. At the same time, €13.5bn of AfT volume from the EU and its Member states, comes €1bn short of the previous year. Efforts need to continue to keep the good share of ODA go to the AfT, not to lose the 1st world AfT donor status

AID TRANSPARENCY INDEX 2020: EFFORTS TO IMPROVE TRANSPARENCY IN EU FINANCIAL ASSISTANCE BEAR FRUIT

The newly published 2020 Aid Transparency Index (ATI) highlights remarkable improvements made by the European Commission, demonstrating its continued commitment to transparency. In particular, the Directorate General for International Cooperation and Development (DEVCO) increased its score by over 10 points from 65.9 to 76.5.

Recent measures for improving transparency have significantly enhanced the EU's performance, including increased access to information such as policy documents and reports, as well as improved availability of budgetary and geolocalisation data.

Improving transparency in the EU financial assistance is an ongoing effort and is essential for ensuring accountability and supporting informed decision making.

COVID-19: EU PROGRAMME PROMOTES DIGITAL SOLUTIONS TO THE CRISIS IN AFRICA

The European Union has announced a €10.4 million programme to promote digital solutions to fight the coronavirus pandemic and to improve the resilience of health and education systems in the Democratic Republic of Congo, Rwanda and Burundi. The programme will promote digital solutions to improve the continuity and quality of both education services through, for example, e-learning, and technical and vocational training. It will also promote digital solutions to enhance the quality and efficiency of health services, such as monitoring and surveillance in the targeted countries.

DG NEAR

UNEMPLOYMENT AND ECONOMIC ISSUES ARE THE MAIN CONCERNS OF AFRICAN YOUTH

Working together with African countries is a priority for the European Union. During Commission President Ursula von der Leyen's first official visit to Ethiopia, she stressed the importance of a partnership of equals, and moving past decades of donor country-aid recipient relations.

Developing a partnership of equals implies understanding the challenges, interests and aspirations of African citizens. This has been the focus of a JRC report assessing the results of a recent Afrobarometer public opinion survey.

DO ENVIRONMENTAL FACTORS INFLUENCE COVID-19 OUTBREAKS?

While laboratory studies have shown that environmental conditions influence the spread of COVID-19, a significant impact of outdoor air pollution on the spreading or severity of the disease has not been demonstrated yet, following a recent JRC study.

The significance of the impact of environmental conditions on the COVID-19 pandemic has still not been established and their influence might have been overestimated in the statistical studies.

SMARTER 2020 CONFERENCE WEBINAR SERIES: CONNECTING GRAND SOCIETAL CHALLENGES WITH LOCAL GOALS IN PLACE-BASED INNOVATION POLICY (ONLINE)

The SMARTER 2020 Conference has been transformed in a series of webinars taking place from September to December 2020.

EU DIGITAL AUTUMN SCHOOL - PROTECTION OF PUBLIC SPACES FROM TERRORIST ATTACKS (ONLINE)

Public spaces are vulnerable. Terrorist attacks have shown a recurrent targeting of public spaces, so-called "soft targets". The EU supports national, regional and urban authorities and operators of public spaces in their effort to protect public spaces to:

- improve security and
- ensure that people can continue their daily lives.

DG TRADE

EU-VIETNAM TRADE AGREEMENT ENTERS INTO FORCE

EU exports to Vietnam will be taxed less. This is the immediate effect of the entry into force of the EU-Vietnam trade agreement that will ultimately scrap duties on 99% of all goods traded between the two sides. Doing business in Vietnam will also become easier for European companies: they will now be able to invest and pitch for government contracts with equal chances to their local competitors. Under the new agreement, the economic benefits go hand in hand with guarantees of respect for labour rights, environment protection and the Paris Agreement on climate, through strong, legally binding and enforceable provisions sustainable development.

COMMISSION LAUNCHES INITIATIVE FOR MORE SUSTAINABLE COCOA PRODUCTION

The European Commission kicks off an initiative to improve sustainability in the cocoa sector. A new multi-stakeholder dialogue brings together representatives of Côte d'Ivoire and Ghana – the two main cocoa producing countries accounting for 70% of global cocoa production – as well as representatives of the European Parliament, EU Member States, cocoa growers and civil society. dialogue aims to deliver concrete recommendations to advance sustainability across the cocoa supply chain through collective action and partnerships. The new dialogue will be supported by technical assistance for cocoa producing countries.

EUROPEAN GREEN DEAL: NEW FINANCING MECHANISM TO BOOST RENEWABLE ENERGY

The European Commission has published the rules for a new EU Renewable Energy Financing Mechanism, to apply from the start of 2021. his Mechanism will make it easier for Member States to work together to finance and deploy renewable energy projects – either as a host or as a contributing country.

The renewable energy generated will count towards the renewable energy targets for both the host and the contributing Member States — with the split based on the share of investment. It offers an opportunity for Member States that are struggling to meet their climate targets to catch up, and to contribute to meeting the overall EU targets. This Mechanism also has lower transaction costs compared to other existing cooperation mechanisms.

COMMISSION PUBLISHES ASSESSMENT OF NATIONAL ENERGY & CLIMATE PLANS

The Commission has adopted an assessment of the EU-wide impact of Member State National Energy and Climate Plans (NECPs) for 2021-2030. The assessment shows that the EU is already on track to surpass its current 2030 greenhouse gas emissions reduction target of 40%. The Commission sees this as a springboard for raising our ambition for 2030, as outlined in the Climate Target Plan.

EU PARLIAMENT & EU COUNCIL

AIDA COMMITTEE TO LOOK INTO THE IMPACT OF ARTIFICIAL INTELLIGENCE ON THE EU ECONOMY

On the 18th of June 2020, the European Parliament set up a special committee on AI, mandating this committee to take a horizontal, long-term approach on the matter. The new Special Committee on Artificial Intelligence in a Digital Age (AIDA) will be composed of 33 members and will have an initial duration of 12 months from the date of the constitutive meeting.

Its mandate is to analyse the future impact of artificial intelligence in the digital age on the EU economy, in particular on skills, employment, fintech, education, health, transport, tourism, agriculture, environment, defence, industry, energy and e-government.

EU BUDGET: PARLIAMENT PUSHES FOR NEW REVENUE SOURCES

As Europe recovers from the coronavirus outbreak, MEPs are insisting on the introduction of new revenue sources to cover the refinancing costs of the recovery instrument, prevent sharp reductions in EU budget expenditure and ensure the Covid-19 response does not become a burden for future generations.

Parliament is proposing new revenue in the form of environmental and financial levies. They include:

- A common consolidated corporate tax base
- Digital services taxation
- A financial transaction tax
- Income from the emissions trading scheme
- A contribution based on non-recycled plastic packaging waste
- A carbon border tax

COUNCIL AGREES ITS POSITION ON THE NEXT EU COMMON AGRICULTURAL POLICY

The Council agreed its negotiating position on the post-2020 common agricultural policy (CAP) reform package. This agreed position puts forward some strong commitments from member states for higher environmental ambition with instruments like mandatory ecoschemes and enhanced conditionality. At the same time, the agreed position allows member states to have the necessary flexibility in how they would reach environmental goals. For instance, there would be a two-year pilot phase for eco-schemes and member states would enjoy flexibility on how to allocate funds under different green practices.

The reform of the CAP foresees that while more flexibility will be given to member states in shaping rules and funding allocations through the development of national strategic plans, they will be obliged to demonstrate a higher environmental ambition compared to the current period. The so-called "new delivery model" would favour performance over compliance: it would enables countries to choose the best tools and actions at their disposal (and also taking into account national specificities) to reach the agreed EU-wide objectives and standards.

OACPS

BILATERAL DISCUSSION BETWEEN UNIDO AND THE ORGANIZATION OF AFRICAN, CARIBBEAN AND PACIFIC STATES (OACPS)



The Director General LI Yong and the Secretary-General of the Organization of African, Caribbean and Pacific States (OACPS), Georges Rebelo Chikoti, agreed to enhance their partnership and to strengthen UNIDO's support for the OACPS Secretariat and Member States in the context of the Post-Cotonou agreement. As UNIDO is tasked to lead the implementation of the Third Industrial Development Decade for Africa 2016-2025 (IDDA III), UNIDO and the OACPS will work closely with over 30 partners to include social, economic and environmental dimensions in development. In the spirit of strengthening multi-stakeholder partnerships, a Summit on Africa's Industrialization and Economic Diversification will take place in November 2020.

NEW AFRICA-CARIBBEAN-PACIFIC/EU PARTNERSHIP: TALKS CONTINUE AT THE HIGHEST LEVEL

The post-Cotonou chief negotiators held another negotiating session online to advance talks towards a new partnership agreement between the EU and the 79 countries of the Organisation of African, Caribbean and Pacific States (OACPS). The meeting brought together Commissioner for International Partnerships Jutta Urpilainen and the OACPS' chief negotiator and chair of the

Ministerial Central Negotiating Group, Prof. Robert Dussey, who is also Togo's Minister of Foreign Affairs, African Integration and Togolese Abroad. The constructive discussions allowed negotiating teams to take stock of progress made, while better understanding each other's positions on the remaining open points. Further progress is expected in the coming weeks as talks will continue at technical level on a daily basis. For their part, chief negotiators are set to meet again by the end of July.

FUTURE AFRICA-CARIBBEEAN-PACIFIC STATES/EU PARTNERSHIP: "POST-COTONOU" NEGOTIATIONS RESUME AT MINISTERIAL LEVEL

The EU and the Organization of African, Caribbean and Pacific States (OACPS), formerly named the ACP Group of States, resumed in June talks at the highest political level, a first since the start of the coronavirus pandemic, with the objective to advance talks towards the finishing line on the new 'Post Cotonou' agreement. The meeting has provided an important opportunity for the chief negotiators, Commissioner for International Partnerships, Jutta Urpilainen, and for the OACPS Professor Robert Dussey to build on the work, which has continued at technical level over the past weeks.

Welcoming this step forward in the negotiation talks, Commissioner for International Partnerships and chief EU negotiator, Jutta Urpilainen, said: "The ongoing negotiations with OACPS countries remain a priority. Despite the disruption caused by the coronavirus pandemic, the negotiations are progressing in the same cordial spirit that has guided our talks until now. I am pleased to see that we are getting closer and closer to the finishing line."

STRATEGIC FINANCIAL ACTORS

THE EIB SUPPORTS EUROPEAN REGIONS AND CITIES IN THEIR RESPONSE TO THE COVID-19 CRISIS AND FOR A GREEN RECOVERY

Recognizing the key role of cities and regions in mitigating the pandemic's effects, the EIB approved exceptional measures to enable a faster approval and disbursement of new loans and allow more flexibility for the use and increase of ongoing loans.

To date, the EIB has approved nearly €25 billion in new financing for COVID-19-related investment to improve public health, strengthen public services and support affected companies. A number of these loans have been or will be directly signed with regional and municipal authorities.

THE JOINT INITIATIVE ON CIRCULAR ECONOMY REACHES OVER A QUARTER OF ITS FIVE-YEAR TARGET AND SUPPORTS GROUND-BREAKING CIRCULAR ECONOMY PROJECTS

After its first year of operation, the Joint Initiative on Circular Economy provided €2.7 billion of long-term financing for projects that will help accelerate the transition towards a circular economy. This initiative launched by the six largest public financial institutions in the EU aims to finance at least €10 billion of investments to support the circular economy over five years (2019-2023).

Members of the initiative are the Bank Gospodarstwa Krajowego (BGK - Poland), the Caisse des Dépôts Groupe (CDC - France), including Bpifrance, Cassa Depositi e Prestiti (CDP - Italy), the European Investment Bank (EIB), Instituto de Crédito Oficial (ICO - Spain) and KfW (Germany).

EBRD PROMOTES INNOVATION IN GREEN TRADE FINANCE

The European Bank for Reconstruction and Development (EBRD) is joining this year's <u>NTT DATA Open Innovation Contest</u> as a partner in the search for potential collaborations with startups who have innovative ideas in the area of sustainable trade finance.

This year, the EBRD is joining the contest as a partner for the first time by providing a <u>challenge</u> – to automate the assessment of its green trade finance transactions. The introduction of automated assessment based on publicly available and searchable databases of green technologies and materials will allow the EBRD to scale up its green trade finance over the coming years.

ECHOES FROM THINK TANKS

UNDERSTANDING THE EU STRATEGY IN THE SAHEL

The August 2020 coup in Mali has once again demonstrated the instability of the Sahel. The region is affected by climate change and rapid population growth. Rivalries over access to livelihoods exacerbate grievances against states. Struggling to provide basic services throughout their territory and security at their borders, governments are competing with armed groups that have emerged from the failed regimes of Central Africa, North Africa and the Middle East. The instability in this region has direct consequences for the security of the European Union's neighbours and for the EU itself. In 2011, the EU adopted the Sahel security and development strategy. While it has contributed to notable progress towards integration and regionalisation, security challenges impeded tangible achievements in preventing radicalisation and fostering development. The Sahel action plan, adopted in 2015 to provide an overall framework for the implementation of the strategy, comes to an end in 2020; its revision (or replacement) will need to take the EU's and Africa's new geopolitical interests on board.

THE VON DER LEYEN COMMISSION'S SIX PRIORITIES: STATE OF PLAY IN AUTUMN 2020

In her statements to the European Parliament in July and November 2019, Commission President Ursula von der Leyen outlined the political priorities that would shape the Commission's work programme for the years 2019 to 2024. The 2020 Commission work programme, adopted before the outbreak of the coronavirus pandemic in Europe, mirrored these priorities. Without changing the overall structure of the six priorities, the spread of the novel coronavirus

(SARS-CoV-2) and its significant impact across Member States obliged the Commission, however, to focus on immediate crisis management. As a result, at the end of May, the Commission adjusted its work programme for 2020, prioritising initiatives that it considered to be essential or necessary for the EU's post-crisis recovery, in line with the Recovery Plan for Europe. The State of the Union debate provides the opportunity to take stock of the progress made thus far and to look ahead.

THE FUTURE OF MULTILATERALISM AND STRATEGIC PARTNERSHIPS

The coronavirus pandemic of 2020 exacerbated global geopolitical trends, including the struggle to uphold multilateralism in a climate of growing nationalism, protectionism and rising great power competition. At the same time, it has demonstrated the need for multilateral cooperation for the effective mitigation of cross-border threats, including health crises. Within this environment, the European Union (EU) has illustrated the relevance of cooperation. Beyond its internal strengthening, the EU has set the defence and reform of multilateralism as one of its key priorities under the current European Commission. This will require coordinated and autonomous EU foreign policy, a smart approach towards the escalating US-China rivalry, reinvigorated cooperation with major democracies, and mobilisation of the EU's foreign policy tools, widely defined. coronavirus leaves parts of the world more fragile and vulnerable, it also precipitates the need for a reformed multilateral system 'fit for purpose' and able to address the challenges of the future.

The Green Deal: Europe's new growth strategy towards a climate-neutral EU by 2050 by UNIDO Brussels

The European Green Deal is an integral part of the Commission's strategy to implement the United Nation's 2030 Agenda and the Sustainable Development Goals. It is designed to protect, conserve and enhance the EU's natural capital, and protect the health and well-being of citizens from environment-related risks and impacts. It resets the Commission's commitment to tackle climate and environmental-related challenges, which the world must cope with today and in the future, including global warming, loss of biodiversity, and pollution.

The coronavirus pandemic has caused a temporary drop in worldwide greenhouse gas emissions. Thanks to the lockdowns, a reduction of the travel and the traffic occurred, the production processes were disrupted and people consumed less. As a consequence, some Member States might achieve the climate goalsthis year, in line with the 2030 climate targets. However, the EU still needs to invest in its long-term future in order to achieve its objective of becoming climate-neutral in 2050.

It entails strategic research and innovation (R&I) investments digital infrastructures, clean energy, circular economy and smart transport systems, which, coupled with the Farm to Fork strategy will help build a more inclusive, sustainable, and resilient Europe.

EU steps up support for Africa's Central Sahel countries

The European Union, Denmark and Germany and the United Nations co-host a virtual Ministerial Roundtable on Africa's Central Sahel region, with the participation of donors and international organisations, as well as the countries concerned: Burkina Faso, Mali and Niger.
